Our Commitment to ESG

Environmental, social, and governance (ESG) investing refers to a set of standards used by socially conscious investors in order to measure a companies impact on its surroundings and screen potential investments.

Our Green Path portfolios are committed to ensuring that the funds we invest in have limited impact on the environment, adhere to social criteria concerning how a company manages its relationships with employees, customers, and their communities, as well as ensuring the company is well governed through reviews of its leadership, audits, and other internal controls.

To do this, we use Sustainability ratings from Morningstar and MSCI, two well-established and well-respected ratings agencies. Morningstar gives each fund a sustainability rating of 1 to 5 globes by reviewing the ESG scores for the individual companies in which the funds invest. Funds selected for our Green Path portfolios carry a rating of 4 or 5 globes.* MSCI ESG ratings range from AAA to CCC. Funds selected for our Green Path portfolios have ratings which range from BBB to AAA.**
