Investment Objective

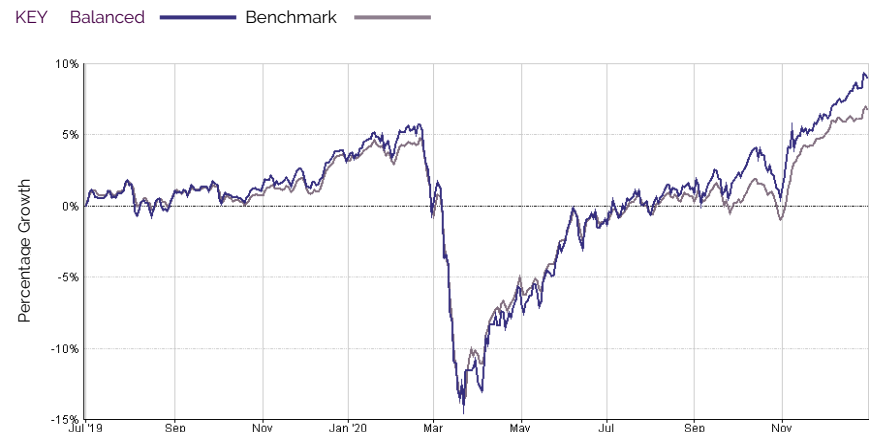

The equity element of this portfolio will not exceed 55%.
